



Logistics. Storages



- Rail: 2 lines directly present in plant territory
 - suitable both for inbound raw material and outbound products, including ships from Klaipeda
- Ship vessels
 - FOB Klaipeda port at Baltic Sea ~50 km, delivery to port by rail or road
 - Loading time for 3800 mt vessel ~36 h
- Road transport
 - trucks, tank-cars / cisterns
- Storages
 - for ethanol products: 3900 mt at plant
 - for raw material: external 0,5 km from plant 20 000 t, max 40 000 t

Investments. Diversification. Universal

Huge investments into new technologies, diversification and automation

- Distillery plant fully renewed during year 2004-2014
 - investments to new equipment 25+ mil. EUR
 - advanced technologies purchased and implemented
 - Main vendors: dehydration, automation German, Japan; rectification and DDGS Ukrainian
 - automated processes during production, both monitoring and control
- Universal production of both top-class / top-quality
 - Rectified alcohol grain ethyl alcohol (food grade)
 - Bioethanol dehydrated ethyl alcohol (fuel-grade, industrial, neutral, denaturated)
- Universal raw material all types of Grain, dry or wet:
 - Corn, Triticale (hybrid of rye&wheat), Rye, Wheat
 - Wet corn using wet milling technologies





Production capacity

Bioethanol (dehydrated ethyl alcohol)	150 000	4,6	54,8	14,5
Rectified ethyl alcohol	120 000	3,6	43,8	11,6

- Production runs switched to one or other product not parallel
- Optimal capacities, including maintenance periods
 - 40 000 m3 E100 / 1 year, with additives 50 000 m3 E100 / 1 year
- Dehydration capacities extra installed are higher
 - 170 000 litres / 1 day, but to use it fermentation needs to be upgraded

Production status

- Production currently paused for 3 years.
 Can be resumed
 - Equipment supervised and serviced since stopped
 - Spare parts for maintenance and replacements are available on-site

- Main reasons of current status
 - Outbound (sales) synchronization issues with Inbound (raw material supply)
 - quantity demanded vs available
 - high fluctuation sales price vs cost
 - no longterms both sales and supply


Owned by MG Baltic
