VISA EXTENSION PROCEDURE IN PAKISTAN

- Visa Policy of Pakistan is approved by the Prime Minister (**Annex-A**)
- Required visa extension form is available on Ministry of Interior's website www.interior.gov.pk & www.dgip.gov.pk
- Visa extension is granted by Visa Section

- To facilitate the foreigners, MOI has established Visa Extension Facilitation Centre at the entrance of P, Q, R & S Blocks of Pak Secretariat;
- Timing of visa Facilitation Centre are 11:00 to 12:00 hrs, daily

- As per Policy, Chinese are exempted from visa fee on reciprocal basis.

GUIDELINES FOR GRANT OF VISA EXTENSION

- **Tourist Visa:**
Extension in Tourist visa for a period of three months i.e. total period of six months inclusive of initial visa period with one or two re-entries.
- **Business Visa:**
Extension upto one year with multiple entries to businessmen visa holders and their family.
- **Extension in stay for foreign students:**
Extension in stay is granted on yearly basis to foreign students admitted on study visas valid for one year with one re-entry on production of required documents.
- **Extension in visa for Missionaries:**
Five years extension with two re-entries per year to foreign Missionaries subject to clearance by Security Agencies/Home Department.
- **Extension to Pakistan Origin:**
Extension to foreigners of Pakistan Origin, spouses and their dependent children (except Indian nationals) for one year with multiple entries.

In rest of the cases, extension is allowed/authorized by the Ministry of Interior.
